A tax rate of \$0.6700 per \$100 valuation has been proposed by the governing body of PECOS COUNTY.

The no-new-revenue tax rate is the tax rate for the 2024 tax year that will raise the same amount of property tax revenue for PECOS COUNTY from the same properties in both the 2023 tax year and the 2024 tax year.

The voter-approval rate is the highest tax rate that PECOS COUNTY may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that PECOS COUNTY is proposing to increase property taxes for the 2024 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON August 19, 2024 AT 10:00 AM AT PECOS COUNTY COURTHOUSE, 103 W CALLAGHAN, FORT STOCKTON, TX.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, PECOS COUNTY is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the PECOS COUNTY of PECOS COUNTY at their offices or by attending the public hearing mentioned above.
