



ORDINANCE NO. 25-109

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF FORT STOCKTON, PECOS COUNTY, TEXAS, AMENDING THE ORDER OF A SPECIAL ELECTION TO BE HELD MAY 3, 2025, IN THE CITY OF FORT STOCKTON, TEXAS, FOR THE PURPOSE OF SUBMITTING PROPOSED HOME RULE CHARTER AMENDMENTS TO THE VOTERS OF THE CITY OF FORT STOCKTON; DESIGNATING POLLING PLACES; ESTABLISHING THE ELECTION PRECINCTS WITHIN THE CITY; APPOINTING AN ELECTION JUDGE AND ALTERNATE JUDGE AND SETTING THE RATE OF PAY FOR ELECTION OFFICIALS, SETTING THE MINIMUM NUMBER OF ELECTION CLERKS AND DESIGNATING THE EARLY VOTING BALLOT BOARD; ESTABLISHING OTHER PROCEDURES FOR CONDUCT OF THE ELECTION; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Home Rule Charter for the City of Fort Stockton, Texas, allows charter amendments in accordance with the laws of the State of Texas; and

WHEREAS, in accordance with Texas Local Government code, Chapter 9, the City Council finds it appropriate to submit proposed charter amendments on its own motion to the qualified voters of the City of Fort Stockton for their consideration: and

WHEREAS, the City of Fort Stockton enters into agreements with Pecos County to conduct the City's elections, pursuant to Chapter 31, Tex. Elec. Code, and Chapter 791, Tex. Gov't Code and such agreements provide for political subdivisions that hold elections on the same day in all or part of the same territory to hold joint elections as authorized in Chapter 271, Tex. Elec. Code; and

WHEREAS, the City of Fort Stockton contracts with the Pecos County Elections Administrator for administration and coordination of any General and Special City Elections; and

WHEREAS, the City Council desires to designate polling places for the election, to appoint the necessary election officers, to establish and set forth procedures for conducting the election, and authorize the City of Fort Stockton to enter into a contract with Pecos County to conduct the election.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FORT STOCKTON, TEXAS THAT:

SECTION 1

Home Rule Charter Amendment Election Called

A Special Election shall be held for the City of Fort Stockton, Texas (the "City") on the 3rd day of May 2025, between the hours of 7:00 a.m. and 7:00 p.m. to consider amendments to the City of Fort Stockton's Home Rule Charter

SECTION 2

Adoption of Charter Amendments

The official ballots for the election shall be prepared in accordance with the Texas Election Code so as to permit the electors to vote FOR or AGAINST the proposition, with the ballots to contain such provisions, marking, and language as required by law and with such proposition to be expressed substantially as follows:

SECTION 4

Appointment of Election Judge, Alternate Election Judge & Clerks

The Presiding Election Judge and Alternate Presiding Election Judge shall be appointed by Pecos County as indicated in the Contract and authorized by Chapter 271 of the Texas Election Code.

The Election Judges to serve at the polling places of said election shall be and are hereby appointed as follows:

- a) In accordance with Section §32.091(a) of the Texas Election Code, the Judges and Clerks shall be paid at the rate of \$15.00 per hour.
- b) There shall be a minimum of three (3) Clerks at the polling place, which includes the Presiding Judge.

SECTION 5
Method of Voting

The Early Voting Clerk is hereby authorized and instructed to provide and furnish all necessary supplies to conduct the special election, in accordance with this Ordinance and the Texas Election Code. Voting at the election shall be by electronic means.

SECTION 6
Early Voting

- a) **Early Voting Clerk.** The Pecos County Election Administrator is designated as the Early Voting Clerk. Additional Deputy Early Voting Clerks may be appointed, as provided in the Contract.

Early Voting by Personal Appearance. Early voting by personal appearance will be conducted each weekday beginning on April 22, 2025, and continuing through April 29, 2025, at the following locations at the designated times:

- c) **Early Voting Ballot Board.** In accordance with Section §87.004 of the Texas Election Code, the Early Voting Ballot Board Judge and two (2) Clerks shall serve as the Early Voting Ballot Board to verify signatures and confirm the count of Early Voted Ballots received.

SECTION 7
Notice

A notice of the Special Election, including a Spanish translation thereof, shall be posted not later than the twenty-first (21st) day before the election on the bulletin board used for posting notices of meetings of the City Council and shall be published at least once, not earlier than the thirtieth (30th) day nor later than the tenth (10th) day before the election in a newspaper published and of general circulation in the City of Fort Stockton.

SECTION 8
Governing Law

This election shall be held in accordance with the Constitution of the United States and the Texas Election Code and all resident qualified voters of the City shall be eligible to vote in the election.

SECTION 9
Necessary Actions

The Mayor and City Secretary of the City, in consultation with the City Attorney, are hereby authorized and directed to take any and all action necessary to comply with provisions of the Texas Election Code or other state and federal statutes and constitutions in carrying out the conduct of the election, whether or not expressly authorized herein.

SECTION 10
Effective Date

The ordinance shall be in full force and effect from and after its adoption.



If a vacancy occurs in the office of the Mayor Pro-Tem, the City Council shall elect a new Mayor Pro-Tem at the next regular meeting after the vacancy occurs.


