WHEREAS, the EVS 6.1.1.0 voting system manufactured by Election Systems & Software, LLC (ES&S) is comprised of the ExpressVote ballot marking device and the DS200 central scanner; and

WHEREAS, Section 123.035 of the Texas Election Code requires that the use of new voting equipment be approved by the Elections Division of the Office of the Texas Secretary of State; and

WHEREAS, Pecos County has received approval from the State of Texas for the purchase and use of the ES&S EVS 6.1.1.0 voting system, which is certified for use in Texas as described in a letter dated July 3, 2019, attached hereto and incorporated herein as EXHIBIT A; and

WHEREAS, the Pecos County Elections Department has purchased the new ADA-compliant ES&S EVS 6.1.1.0 voting system for use by the City of Fort Stockton in the conduct of all municipal elections; and

WHEREAS, pursuant to Section 123.001(b) of the Texas Election Code, the City of Fort Stockton is required to formally adopt the voting system to be used in its elections;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT STOCKTON, TEXAS; THAT:

The City Council of the City of Fort Stockton hereby adopts the ES&S EVS 6.1.1.0 voting system, as certified by the State of Texas, for use in all elections conducted by the City of Fort Stockton.
